#### Mode of Payment

**Fees will not be accepted in cash. Any student depositing cash in a bank directly into SIT account will be doing so at his/her own risk. This will also not be accepted as fees.**

1. Demand Draft drawn in favour of Symbiosis Institute of Technology, payable at Pune.
2. Online transfer: **Step 1-** Transfer the specified amount to the following bank account-

Kindly note that student not sending screenshot of fund transfer UTR/IMPS/RRN to SIT Accounts, will be doing so at his/her own risk. Unless SIT accounts gets the screenshot, it will be treated as fees not paid.

There is separate table for fees payable by International Students. **The facility for payment of fees through Bill desk Portal Payment is not available for Lateral Entry Students.** They will have to make payment as instructed above.
